INFORMATION ON THE PURCHASE OF TREASURY SHARES DURING THE PERIOD BETWEEN AUGUST 12 AND 16, 2024

Rome, August 16, 2024 – Sostravel.com S.p.A. (Euronext Growth Milan, ticker: SOS and OTCQB New York, ticker SOSAF), a digital operator offering booking services, digital itineraries including flight and airport information, car rentals, experiences, and proprietary services such as Lost Luggage Concierge through the Sostravel and Flio apps as well as the platforms <u>www.sostravel.com</u> and <u>www.amare.travel</u>, ("Sostravel.com" or the "Company"), announces that during the period above, 1,250 of its shares were purchased on the Euronext Growth Milan ("EGM") market, organized and managed by Borsa Italiana S.p.A., at a weighted average price of Euro 1.0380, for a total value of Euro 1,297.50. These transactions were carried out under current regulations and within the authorization to purchase and dispose of own shares as resolved by the Company's Shareholders' Meeting on April 27, 2023.
