

## PRESS RELEASE Sostravel: Notification of Change in Share Capital

Rome, October 2 2024 - SosTravel.com S.p.A. (Euronext Growth Milan, ticker: SOS), a digital operator in the market of air passenger assistance services ("Sostravel" or the "Company"), announces the new composition of its share capital following the filing with the Varese Companies Register of the certification of the capital increase pursuant to Art. 2444, paragraph 1, of the Italian Civil Code. This filing, completed today, results from the exercise of the Sostravel 2021-2024 Warrants – ISIN IT0005446718 (hereafter also referred to as the "Sostravel Warrant") up until September 30, 2024.

The change in share capital occurred following the issuance of 160 Sostravel ordinary shares (ISIN IT0005338675), with no nominal value, arising from the exercise of 160 Sostravel Warrants during the month of June of this year.
